Cy Nunnally Memorial Airport

The Cy Nunnally Memorial airport is still in the process of expanding hangar sites and hangar capacity. The single site is nearing completion, while the now 12-unit t -hangar site is still in the construction phases. Once complete, the airport's based aircraft county should expand to over 50 aircraft for the first time ever. This number helps with leverage for grant funding opportunities at both the state and federal levels.

The Cy Nunnally Memorial Airport was recently awarded grant funds in the amount of \$1,253,417.00 for the complete rehabilitation of runway 3/21 in the state's 2021 budget cycle. The City of Monroe will be responsible for \$52,417.00 of matching funds for the project. This project is currently in the bidding phase as bids close on December 17th with the evaluation process to follow. Recommendation for award will come before City Council in January of 2021 for final approval prior to construction in the spring of 2021.

November of 2020 will see the submission of the Airport Fuel Tax Certification by the City of Monroe. This entails providing proof that all tax dollars collected from the sale of fuel by the airport is then used for airport improvements in the following year. The city has always met this requirement easily in the years since the installation of the 100-LL AvGas fuel farm in 2015. The city is also responsible for submitting Capital Improvement Project schedules to the DOT during the month of November that both requests grant funding from the federal and state levels but unofficially declares the city willing to provide a percentage of matching funds should grant funds be awarded. As schedules are generated, the airport undergoes routine inspections by the state to determine compliance and list of required improvements that may need addressing in a reasonable period of time. The current scheduled inspection for the airport is in early February of 2021, but is subject to change based on outside factors.

In the past several years there have been projects related to apron rehabilitation and expansion on the east side of the runway, taxi lane relocations on the west side, drainage repairs, and now a complete rehabilitation of runway 3/21. The total grant funds received for these projects are approximately \$2,339,667.23 from both federal and state funds. The City has leveraged these funds received with a local contribution of \$509,797.83 thus allowing for larger projects to be performed.

In January 2020, the City of Monroe voted to officially take back control of all Cityowned parks from County management and oversight. The initial plan for the City of Monroe is to assess the condition of those parks and to then provide an overall maintenance and rehabilitation plan. The primary focus at the outset is safety, followed by the usability of functions and facilities, and to finally rehabilitate those parks throughout the years to come. Major projects at all parks will be funded by the 2019 SPLOST as provided for by the tax. Budgeted projects will then be discussed and presented to City Council as achievable based on funding availability.

On October 19th, Pilot Park on High School Avenue was reopened to the public as



all of almost the complete components rehabilitation were complete! The only remaining elements are to paint the new fencing that is in place and then to add a few shade structures in the early months of 2021. The park project was approved for \$250,000 and completed for approximately \$262,317 as a few adjustments were made with the addition of decorative trees, border shrubs, and storm drainage on the back corner were repaired. The finished product has been an overwhelming success and a perfect example of

what's to come with the City parks system in the future!

The next larger phased park project has been ongoing at Mathews Park. It was approved for \$175,000 for improvements that include additional playground

equipment, new swings, benches, picnic tables, grills, flag pole, painting, signage, and new restroom facility. Final numbers should be close to \$158,063 for completion. Currently, the park areas are open with the new restroom facility in production and slated to arrive





very end of 2020 or early 2021. At that point, the initial phase of Mathews Park is complete, with additional elements and changes planned for the future. This will include bike and walking trails, additional pavilion space, new parking and paved areas, the restock of the

lake for fishing, and other elements as determined based on need and spacing.

Another park of note for improvements is that of the Green Street park. New basketball goals have been installed as well as new swing elements. In 2021, the plan is to rework the court itself to level the existing area, restripe the lines, and to add seating on each side of the court potentially as space allows. Based on funding, a few additional playground elements will be added as well with improved fencing.

The parks system improvements have been both exciting and rewarding for everyone! Improvements are coming to other parks and areas around town, and can be done as funding becomes available.
