## Cy Nunnally Memorial Airport


Every five (5) years, the Georgia Department of Transportation (GDOT) requires municipal governments to advertise a Request for Qualifications (RFQ) for airport consulting and engineering service firms, per grant funding requirements. The City of Monroe recently completed its selection process for an airport consulting and engineering services firm to assist with projects at the Cy Nunnally Memorial Airport for FY2020-24. The selection process involved four (4) steps.

First, consulting and engineering firms were invited in an RFQ publishing to submit a Statement of Qualifications to the City for consideration. The RFQ includes a list of anticipated projects that a consultant could reasonably expect to participate in during that term. Interested firms have approximately 30 days, no less, from the date of the advertisement posting to submit a Statement of Qualifications explaining their interest, experience, and qualifications to work with the City. Specifically, the most recent RFQ asked for a company description, a list of key personnel in the company, personnel qualifications, relevant project experience, references, and familiarity with Federal Aviation Administration (FAA) and GDOT regulations. The City received four (4) submissions from firms seeking to provide this service. The firms were rated based on their responses to each of the above criteria. Second, the submitted Statement of Qualifications were reviewed and rated. Third, representatives from each of the four (4) firms were invited to Monroe for a presentation and interview. For the presentation, the firms were asked to address several key topics specific to the Cy Nunnally Memorial Airport. Those topics were as follows:

- Terminal building location and general design
- LPV approach acquisition
- T-Hangars, storage, and alternatives
- Capital Improvement Plan (CIP) structure recommendations

- Airport growth and increasing overall economic impact
- Funding solutions for all of the above

Each of these topics comes from the proposed projects for the FY2020-24 CIP for the airport. In other words, the firms were asked to consider the projects that they may actually be working on with the City and come up with creative, practical, and cost-effective solutions. Lastly, the firms were rated based on presentations, and then combined with initial ratings for an average with one (1) firm being selected. The highest rated firm was Goodwyn, Mills, and Cawood (GMC). GMC is an architectural and engineering services firm with offices throughout the southeast, including four (4) in Georgia. The City of Monroe has employed GMC for engineering services on several occasions including an efficiency study at the Jack's Creek Wastewater Treatment Facility, current water tank maintenance contracts, and have relocated and/or designed several natural gas lines for the City. We are excited to begin working with them at the Cy Nunnally Memorial Airport!

## Monroe-Walton County Library



## **NATURAL GAS**

Natural gas usage has grown in the United States over the past decade mostly due to its falling cost, abundance, and reliability as an energy source. Natural gas usage is growing rapidly worldwide since it can be used for heating, cooking, and the production of electricity. Most of the southeastern United States obtains its natural gas supply from the Transcontinental Pipeline that runs from Texas to Pennsylvania. The pipeline actually runs through Monroe and Walton County!

People use natural gas for heating, hot water, and cooking every day, but what is it exactly? Natural gas is a fossil fuel hydrocarbon gas formed under the surface of the Earth's crust, most often released and captured during hydraulic fracturing (fracking) operations. Natural gas produces carbon dioxide emissions when it is burned, but it produces fewer CO<sub>2</sub> emissions than coal or oil. Over the past decade, natural gas has become the cheapest and most abundant source of energy in the United States.

Natural gas is colorless and odorless naturally, but natural gas that goes into homes is infused with an odorant called mercaptan. Wercaptan smells like rotten eggs, and it makes natural gas leaks easier to locate. Take action immediately if you detect a rotten egg odor in your home!!!
