# **CODES AND ORDINANCES**

The City of Monroe Code Office has the duty of enforcing the Codes of the City of Monroe.

We believe that the majority of citizens are in compliance with the code or will comply once informed. Our goal is to inform the community in order to achieve voluntary compliance.

Once a written report of a code violation is made, the code office will notify the responsible person(s) of the violation and inform them on how to gain compliance. If voluntary compliance is not achieved in a specified time period, the responsible person(s) is issued a citation and ordered to appear before the Judge of the Municipal Court.

If you are in violation of city code, you will be notified by repair and cleanup notice posted on the property and/or by mail. For non-hazardous violations, the first letter is a courtesy notice. It is intended to advise that a violation of a law or municipal code(s) has been observed. If you receive one of these letters, you may contact the Code Enforcement Office at (770) 207-4674 with any questions you may have.

This letter will also inform you of the date by which the issue needs to be corrected. If the violation is not corrected by the date given, you will receive a citation. The fine will not exceed \$1,000. Our goal is to have citizens voluntarily abate violations without taking further enforcement action.

Each citizen has the right and is encouraged to report code violations online at www.monroega.gov. Reports may also be made by telephone or in person to the code office.

For citizens who may need financial assistance meeting code requirements or need help with general repairs, the United States Department of Agriculture (USDA) offers a program that may serve as a resource to help for home repair. This provides loans to very-low-income homeowners to repair, improve, or modernize their homes or grants to elderly very-low-income homeowners to remove health and safety hazards. #### Code violations can come in a variety of forms. Some of them include:

- Tall grass and weeds
- Junked or abandoned vehicles
- Tree limbs and brush
- Trash and debris
- Trespassing
- Substandard and dangerous buildings
- Sign code violations
- Fence maintenance
- Zoning ordinances violations

# What's Cold Got to do With it? Cold and the Cost of Utility Bills

During the next few weeks, residents will see an increase in their Utility Bills. Here are a few answers to questions as to why they increased.

The simple truth: it was cold! During the month of January, the state of Georgia experienced extremely low temperatures. There were at least 16 days where the temperatures were below freezing. This is what contributed to the increased usage, which increased the bill! 16 days below freezing Energy use is directly tied to temperature. Because of repeated Arctic Blasts, the first 18 days of the month required

twice as much heat

as last year!

Heat systems in Georgia don't like to work hard. Anyone living in Georgia knows how unpredictable the weather can be. One day it's 41 degrees, and the next day it's well, 20 degrees and dropping. In Georgia, the heat systems are not designed to work below 40 degrees. The systems are called air source heating systems. They work two ways. When it is about 40 degrees or higher, the heat pumps work fine in ensuring that homes stay warm. Heat pumps are energy efficient and will heat a home at little expense. When the temperature drops, heat pumps stop working efficiently. When this happens, heat strips come on. Heat strips consume about three times as much energy as a heat pump while producing the same amount of heat. In essence, when the heat strips come on, the system uses more energy to keep the house warm. This is what contributes to usage going up as well. This is the same for space heaters and window units; they cause usage to spike as well. Remember, as usage goes up, so does the bill.

The City of Monroe issues checks for a variety of reasons whether it be for payments or refunds. We generally will mail these payments to the address that we currently have on file. In some cases individuals or companies may have moved and the checks are returned to the City of Monroe or are never cashed or deposited. #### WHAT'S HAPPENING

You have seen the construction barrels and cones, along with some right-of-way work on West Spring Street. Our sidewalk project including street lights is coming along and will be running from Childers Park to White Oak Lane.

Our North Broad sidewalk beautification project will be underway this summer. Once complete, the remaining planned project is East Spring Street at Walton Plaza. I will keep you up-to-date as this project is scheduled.

Land acquisition will begin this summer for our truck route that runs from Hwy 83 to Hwy 11. As this is in the hands of the state Department of Transportation, we are at their mercy. However, we are anticipating construction to begin mid-year, 2020.

I have a personal goal to add to our parks; we will be working with your city of Monroe management to fund these upgrades. We are looking at additional playground equipment, perhaps a splash pad, and additional maintenance to beautify our system-wide network of parks (from Childers to Hammond to Pilot).

Of course, by now, you have heard that Monroe will be getting its first national hotel brand. Going on the corner of Spring Street and Bankers Blvd., the Hampton Inn will have 80 rooms to help accommodate our guests from out of town. Construction should begin by the end of the year.

#### ONE MONROE

Keeping everybody in the loop: One of the things that was most often mentioned during campaign season was the need to clean up our town. Regarding our efforts to clean up the city, please take a moment to download the new City of Monroe 311 app on your smart-phone; this will allow you to easily report code violations or repair requests (sidewalks / potholes)—here, you can even receive and pay your utility bill through the app.

Taking cleanup into consideration, we have asked our Code Department to give notices of all code violations. Instead of picking on one person or neighborhood, we have actively given out more than 200 notices all over town in the last few weeks. Most of these violations are very simple, low-cost fixes.

As the economy has picked up pace, our city has gotten safer. In 2017, we had an overall crime decrease in the city of 22%. Not only do I applaud our officers (including the Walton County Sheriff's Office and the GA State Patrol), I applaud you!

At the same time, we have asked our team to really focus on trash clean-up. While our guys are doing their part, it is up to each of us to keep Monroe clean. Monroe is in good shape at the moment. Property values are going up; however, the more we can do to enhance our properties and streetscapes, the more desirable our city.

## **Creating a Walkable Monroe**

The City of Monroe is making the city more walkable! The City has begun the side walk project

on Spring Street from Jackson Street to the Paradise Shoppes Shopping Center. With this project, the City will make provisions for pedestrianoriented facilities such as sidewalks and multi-purpose paths. The enhancements will make it easier for pedestrians traveling to the City Center by way of foot-traffic. It will provide a safe alternative to driving for enjoying all of the many attractions Monroe has to offer.
