- Possession of or ability to readily obtain a valid driver's license issued by the State of Georgia for the type of vehicle or equipment operated. Possession of or ability to readily obtain a flagging certification.

- Understanding of departmental & safety rules & regulations.
- Knowledge of refuse collection procedures & materials that cannot be processed in the truck.
- Ability to operate equipment used for unloading & cleaning refuse trucks.
- Skilled in using hand tools such as rakes, shovels & brooms.
- Ability to effectively communicate with team members.

### **Duties & Responsibilities:**

- Ride with a refuse truck to collect refuse, push carts to the truck, place carts on hydraulic lift, & return carts to curbs.
- Assist driver in safely backing the truck by providing clear directions.
- Serve as flagger to safely direct traffic.
- Assist in unloading the truck at the landfill.
- Assist with maintenance of the truck & repair of garbage carts.
- May operate a non CDL garbage truck or knuckle boom truck.
- May assist with maintenance of city streets.
