#### Recommendation:

Staff recommends the APPROVAL of this request based on the information provided for installation of the plastic gas line for replacement of the steel gas line. Bids were sought in accordance with the Procurement Policy and sufficient funds are available in the CIP Budget for 2016.

#### Background:

It is the practice of the City of Monroe to continually replace steel gas lines with plastic gas lines. The GW Carver Drive and Green Street steel gas lines were installed in 1964. Routine and recent cathodic protection (CP) surveys have revealed low CP readings in the area, as well as a number of leaks being present in the recent leak survey taken of the line. Several attempts to repair the line in areas has been made, with little to no success in generating acceptable CP readings of at least -.850 milivolts. Readings of -500, -533 and -270 are still present on the lines, thus being far from the acceptable CP reading.
